Instructions to Bidders, Contents of Bidding Documents, Amendment of Bidding Documents of the Procurement Documents, Public Investment Management Office, No. 11 Nemanjina street, Republic of Serbia, as the Purchaser, hereby notifies all persons concerned for **Procurement of medical equipment for Clinical-hospital centre “Dr Dragiša Mišović-Dedinje” IOP/59-2021/UHI**, that there has been an amendment made in the Procurement Documents.

The following provisions of Tender Documents are hereby replaced as follows:

1. **Tender Documents are changed in Technical Specification, Lot 1, Surgery, Line item no. 1.4, ID 1.4.1 - Endoscopic ultrasound system with Linear ultrasound gastroscope, no. 70, which reads as follows:**

- Viewing angle 180° /180°

**It is replaced and reads as follows:**

- Viewing angle 178° /178°

2. **Tender Documents are changed in Technical Specification, Lot 1, Surgery, Line item no. 1.7, ID 1.7.1 - Lithotripsy device, no. 7, which reads as follows:**

- Lithotripsy Probe, Reusable, 1.50 mm (4.5 Fr), length 564 mm, 6 pc

**It is replaced and reads as follows:**

- Lithotripsy Probe, Reusable, 1.50 mm (4.5 Fr), length 564 mm, 1 pc

3. **Tender Documents are changed in Technical Specification, Lot 2, Hospital wards, ID 2.8 - Bedpan washer – disinfectant:**

- New quantity is 6

4. **Tender Documents are changed in Technical Specification, Lot 2, Hospital wards, ID 2.14.2. - Infusion syringe pump:**

- New quantity is 27

In all other aspects, Tender documents for the **Procurement of medical equipment for Clinical-hospital centre “Dr Dragiša Mišović-Dedinje” IOP/59-2021/UHI**, remains unchanged.
