Question 1:

Documentary evidence of employment:

Please note that due to strict privacy rules we are not allowed to send copies of M-forms or other documentary evidence of employment (such as for example labour contracts) as proof of employment of at least 5 suitably qualified personnel,

Kindly confirm if a statement from our CEO (also the legal representative of our company as well as the person signing our bid) concerning the numbers of suitably qualified employees as well as the starting date of their employment is sufficient in this matter.

 Pursuant to Article 3 of the Framework Loan Agreement LD 1981 (2018) between the Council of Europe Development Bank and the Republic of Serbia for Public Sector Financing - Improvement of Health Care Infrastructure in Serbia, and the provisions of the Tender Documentation in the public procurement procedure: Procurement of equipment for General Hospital in Arandjelovac", number IOP/60-2021/UHI, it is defined that the Purchaser is not able to use the loan funds to pay taxes, duties or other fees.
