4. Part I Section 2. Qualification Requirements, in the part related to meeting the qualification requirements by Joint Venture and Subcontractor, has been changed and now reads as follows:

"Members of a Joint Venture could meet Consultants qualifications requirements cumulatively in order for the Joint Venture to qualify.

The leading member of a Joint Venture must hold a valid certificate covering its relevant operations on the assignment: ISO9001. Other members of a Joint Venture are not obliged to hold a valid certificate covering its relevant operations on the assignment: ISO9001.

A consistent history of litigation or arbitration awards against the any member of a Joint Venture may also result in disqualification of the Joint Venture.

Subcontractors' qualifications, experience and resources *will not be taken* into account in determining the Consultant's compliance with the qualifying criteria, unless specifically stated in the points above."

In accordance to the above-mentioned, the Procurement Notice has been appropriately harmonized.

In all other aspects, Procurement Document for the procurement of consulting services: Feasibility Study of "Construction of a new University Children's Hospital in Belgrade", number of the procurement IOP/16-2018/UCH, remains unchanged.
