As documentary evidence you demand for each qualified person (1) copy of certificates for offered system model and M form or copy of labour contract. What you mean by certificate?
 - This provision is not applicable for this type of furniture, it is applicable for devices where certifications are issued.
- **2.** Whether the provider must also be a manufacturer of medical equipment or can offer equipment and certificates from a company specializing in medical equipment?
 - No, it is not necessary that provider is a manufacturer of medical equipment.
- 3. Do all documents (evidence) have to be translated into English?
 - Language for translation of supporting documents/documentary evidences and printed literature is English or Serbian, except for documents and evidences made in Serbian or issued by the relevant authority in Serbian language.
- 4. Are you translation of a court interpreter is required?
 - If the documents are issued in languages different form Englis or Serbien, it is necessary to provide translation by court interpreter.
- 5. Do we have to give a catalog (picture or drawing) with descriptions for each item offered or we can provide a statement of the matching offered with the required equipment?
 - It is necceassary to provide to catalog or picture or drawing, statement is sufficient only for the part of specifications that is not in catalog.
- 6. In which currency should be the bank guarantee?
 - The guarantee currency should be in EUR.
- 7. Shelf unit for storage of archive-What is the RAL of shelf unit (color of plastification)?
 - Shelves should be in RAL 9003 or appropriate
- 8. Locker for personal clothes-Please provide more detailde description-does the locker have

storage shelf, werdrobe rail, and hooks for clothes hanging and RAL?

• Locker should have storage shelf in upper part of wardrobe and hanging rail or hooks

for clothes hanging, RAL should be in RAL 9003 or appropriate

 - RAL should be RAL 9003 or appropriate

If so, please provide picture of such required goods.
 - Armrests are as in description of the goods, PVC armrests with chrome-plated part.
- 11. Office chair, movable, with height adjustment, and without armrest-You provided same desciription as for previous chair, including armrest: What is the final description of office chair without armrest?
 - It is a technical error. Chairs under point should be without armrests.
- 12. Waiting room chair-You provide picture of three seater without armrest, while you have described just one chair with armrest. These type of waiting chairs are always without armrest.Please provide us information does the total quantity od 193 chairs
 (polyclinic,neurology, and pediatrics) relate to : two seater three-seater, four-seater, and more. The price is different for each one of this, and there is no one-seater chair in category waiting chairs.
 - Position 14- total ammount of seats 146, 32 three-seater and 25 two-seater
 - Position 16- total ammount of seats 12, 4 three-seater
 - Position 21 total ammount of seats 35, 3 three-seats, 13 two-seats

Unit price is price of one single seat.
