QUESTION 1:

Today, the representatives of our company visited the site and considered the complexity of the location in terms of existing installations, the facility to be demolished, the levelling of the surrounding terrain, internal roads, unknown soil composition to fund the new facility, etc.

Based on the collected information from the site visit, and since the design and construction works are an integral part of the project, quality reviewing of the complete scope of work and all relevant available data, requires more time than the defined bid submission deadline.
